## Legislative Update

### House Bill 27 - Prohibit Workers Compensation for Undocumented Immigrants

The Ohio House of Representatives recently voted 65-29 along party lines to approve the two year workers' compensation budget bill. HB 27 includes provisions that would 1) prohibit undocumented immigrants from receiving workers' compensation benefits if hurt on the job, 2) prohibit an employer from electing to cover an undocumented immigrant, 3) grant an employer immunity for liability for damages suffered by reason of personal injury sustained or occupational disease contacted in the course of employment caused by the employer's wrongful act or omission unless the claimant establishes that the employer hired the individual knowing that the individual was not authorized to work under federal law. The bill is under consideration in the Senate, and proponent testimony will be heard this afternoon. The Insurance and Financial Institutions Committee will hear opponent testimony in the near future.

### **House Bill 138 - Wage Discrimination Complaints**

HB 138 would establish a toll-free equal pay hotline that would allow workers to make anonymous complaints regarding employers discriminating in the payment of wages. The hotline would be operated through the Ohio Civil Rights Commission, which currently files individual or group charges of discrimination for investigation. "Ohio workers should be able to discuss their salaries and report discrepancies without fearing they will be treated different, demoted or fired," said sponsor Rep. Janine Boyd. This legislation has been referred to the House Economic Development, Commerce and Labor Committee where it awaits a hearing.

### **House Bill 164 - Commercial Roofing Licensure**

HB 164 would require the licensing of all commercial roofing contractors. Contractors would have to satisfy the same requirements that other specialty contractors must satisfy under continuing law, including passing an examination and would require that person to assign the license to the contracting company that employs the person. The licensing board would consist of five members, one of whom is a building inspector employed by either the department of commerce or a municipal corporation, two roofing contractors without union affiliation, and two roofing contractors with established union agreements. The House Economic Development, Commerce and Labor committee has held one hearing on the bill.
